## ABOUT TARSUS AND SJÖBLOMS SJUKVÅRDSUTRUSTNING AB

To whom it may concern:

Our formal family company is called **Sjöbloms Sjukvårdsutrustning AB** (meaning "Sjöbloms Medical Equipment Inc."). **Sjöbloms** is actually the owner's family name). The root of this company goes back to 1948.

1989 we started a physiotherapy table division which we branded **Tarsus Products AB**.

When the two companies were formed into a company group under one owner some years later, we decided from a practical standpoint to market all our products under the simple name **Tarsus** instead of Sjöbloms Sjukvårdsutrustning AB (which is impossible to pronounce outside of Scandinavia).

All finance, all certificates like ISO and all production formally go through company Sjöbloms Sjukvårdsutrustning AB.

Marketing-wise, however, we use both names: Sjöbloms Sjukvårdsutrustning AB in Sweden / Norway, and Tarsus outside of Sweden/Norway, since both of them are so well known in their respective field.
